**MUNICIPAL ORDINANCE NO. 185**  
Series of 2003

**AN ORDINANCE REGULATING GARBAGE DISPOSAL AND COLLECTION IN THE MUNICIPALITY OF MALAY.**

SECTION 1. - **REGULATORY ACT.** It shall be prohibited of any individual, household, business establishment or any entity to dispose their respective garbage and other residue not in accordance with the regulatory policies mandated by this ordinance and/or guidelines set by the duly constituted municipal offices.

SECTION 2. - **GARBAGE HANDLING/SEGREGATION.** It is mandatory that individuals, households, business establishments and/or other entities shall segregate their respective non-biodegradable/non-compostable from biodegradable/compostable garbage and other residue. For safety and sanitary purposes, this segregated garbage and/or residue must have an appropriate separate receptacle or container.

SECTION 3. - **GARBAGE HANDLING/COMPOSTING.** It shall be mandatory of all individuals, households, business establishments and other entities with a backyard open space of no less than 50 square meters to maintain a modest composting bin or pit for their respective biodegradable garbage and residue. It shall however be the primary duty of the said entities to maintain safety and sanitary practices in operating such composting bin or pit.

SECTION 4. - **GARBAGE DISPOSAL/COLLECTION.** Individuals, households, business establishments and/or other entities shall bring out their respective segregated garbage or residue for pick up in accordance with this ordinance and/or schedule and scheme formulated and implemented by the concerned municipal office or agency. It shall be the duty of the aforementioned entities to maintain safety and sanitary practices in handling garbage and other residue while waiting for pick up.

SECTION 5. - **SCHEDULE. CLASSIFICATION. BRINGING OUT AND COLLECTION OF SEGREGATED GARBAGE AND/OR RESIDUE.** Bringing out and collection of segregated garbage and/or residue shall follow the following schedule:

A) **SCHEDULE FOR BRINGING OUT OF SEGREGATED GARBAGE AND/OR residue:**

Along the beach/path road	- between 4 AM to 5 AM
Designated collection points	- between 4 AM to 6 AM
Other areas	- between 5 AM to 10 AM

It shall be mandatory however for individuals, households, business establishments and/or other entities not to bring out their respective garbage and/or residue once the garbage truck has already passed by for garbage collection purposes.

B) **COLLECTION SCHEDULE:**

Along the beach/path road	- between 5 AM to 6 AM
Designated collection points	- between 5 AM to 8 AM
Other areas	- between 5 AM to 10 AM

An extra garbage truck trip shall be made in all areas at 3:00 PM but only to collect construction debris, dry garden wastes, drift wood and similar garbage.

Biodegradable garbage and residue shall be collected daily while non-biodegradable garbage shall be collected every Thursday only.

SECTION 6. - **PENALTY.** Violation of any provision of this ordinance shall suffer the following penalties:

A) **FOR SECTIONS 1, 2, 4 AND 5;**

- 1) Non-collection of garbage or residue
- 2) Fine of TWO THOUSAND FIVE HUNDRED PESOS (₱2,500.00) per infraction.

Garbage not collected as part of a penalty for violation shall be brought to the dumping site by the violating entity at his/her own expense.

B) **FOR SECTION 3;**

Penalty of TWO THOUSAND FIVE HUNDRED PESOS (₱2,500.00) and cancellation of Mayor's business Permit for continued defiance. For purposes of this ordinance, continued defiance shall mean refusal to take positive action after three (3) notices of violation.


SECTION 7. - **REPEAL/AMENDMENT.** Any ordinance, rules and regulations, or parts thereof, whose provisions are in conflict with, or contrary to the provisions of this ordinance are hereby repealed, amended and modified accordingly.

SECTION 8. - **EFFECTIVITY.** This ordinance shall take effect upon approval and proper publication.
