**MUNICIPAL ORDINANCE NO. 275**  
Series of 2009

**AND ORDINANCE ADOPTING R. A. NO. 8550 OTHERWISE KNOWN AS "THE PHILIPPINE FISHERIES CODE OF 1998."**

SECTION 1. - **RATIONALE.** Taking into consideration the applicability of the provisions of R.A. No. 8550 in protecting and conserving of the aquatic products within the territorial jurisdiction of the Local Government Units, by way of regulation, this Sangguniang Bayan deems it proper to adopt the Philippine Fisheries Code of 1998 as part of its local ordinances.

SECTION 2. - **R.A. No. 8550. ADOPTION.** R.A. No. 8550, the Philippine Fisheries Code of 1998, is hereby adopted as part of the local ordinances of the Local Government of Malay.

SECTION 3. - **PENALTY.** Any person caught violating pertinent provisions of R.A. No. 8550 shall be punished by a fine of TWO THOUSAND FIVE HUNDRED PESOS (•2,500.00) or an imprisonment of six (6) months or both depending upon the discretion of the court.




