**MUNICIPAL ORDINANCE NO. 234**  
 Series of 2005

**AN ORIDNANCE AMENDING SECTION 5, PARAGRAPH B(2) OF MUNICIPAL ORDINANCE NO. 144, SERIES OF 2001, AN ORDINANCE DECLARING BORACAY ISLAND AS A NOISE SENSITIVE ZONE AND ADOPTING THE RULES AND REGULATIONS OF THE NATIONAL POLLUTION CONTROL COMMISSION PERTAINING TO NOISE.**

SECTION 1. - **RATIONALE.** Night time schedule, from 10:00 p.m. to 5:00 p.m., as provided by Section 5, Paragraph b(2) of Municipal Ordinance No. 144, series of 2001, is erroneous, hence this amendment.

SECTION 2. - **AMENDMENT.** Section 5, Paragraph b(2) of Municipal Ordinance No. 144, series of 2001 is hereby amended to read as follows:

"2) The division of the 24 hour period shall be as follows:

- Morning . . . . . 5:00 a.m. to 9:00 a.m.
- Daytime . . . . . 8:00 a.m. to 10:00 p.m.
- Evening . . . . . 6:00 p.m. to 10:00 p.m.
- Nighttime. . . . .10:00 p.m. to 5:00 a.m.

SECTION 3. **EFFECTIVITY.** This Ordinance shall take effect upon its approval.


