MUNICIPAL ORDINANCE NO. 242
Series of 2006

AN ORDINANCE DESIGNATING MALAY MUNICIPAL PLAZA AT POBLACION, MALAY, AKLAN AS FREEDOM PARK IN THE MUNICIPALITY OF MALAY IN ACCORDANCE WITH SECTION 15 OF BATAS PAMBANSA BLG. 880.

SECTION 1. - **MALAY MUNICIPAL PLAZA. FREEDOM PARK.** Pursuant to Section 15 of Batas Pambansa Bilang 880, otherwise known as *The Public Assembly Act of 1985*, Malay Municipal Plaza at Poblacion, Malay, Aklan is hereby designated as the Freedom Park in the Municipality of Malay.

SECTION 2. - **FREEDOM PARK. PURPOSE. UTILIZATION GUIDELINES.** The purpose and guidelines in the utilization of the designated freedom park as provided by Section 15 of Batas Pambansa Blg. 880 and Department of the Interior and Local Government Memorandum Circular No. 2006-42 are likewise adopted as part of this ordinance.

SECTION 3. - **EFFECTIVITY.** This ordinance shall take effect upon its approval and proper publication.


