**MUNICIPAL ORDINANCE NO. 244**  
 Series of 2007

**AN ORDINANCE PRESCRIBING FEES FOR BIDDERS ANY LGU-MALAY FUNDED PROJECTS AND PROGRAMS SUBJECT TO BIDDING REQUIREMENTS.**

SECTION 1. - **RATIONALE.** LGU-Malay incurs expenditures in the conduct of biddings for municipal projects and programs hence the need for this ordinance to recover the afore-cited cost.

SECTION 2. - **BIDDING FEE SCHEDULE.** Participants in all LGU-Malay biddings shall pay appropriate bidding fees as prescribed in the schedule below:

**A) ON SUPPLIES AND MATERIALS:**

Up to 250,000.00	₱ 300.00
Over 250,000.00 to 500,000.00	400.00
Over 500,000.00 to 750,000.00	500.00
Over 750,000.00 to 1,000,000.00	1,000.00
Over 1,000,000.00 to 2,000,000.00	1,500.00

**B) ON INFRASTRUCTURE:**

Up to 250,000.00	750.00
Over 250,000.00 to 500,000.00	1,000.00
Over 500,000.00 to 750,000.00	1,500.00
Over 750,000.00 to 1,000,000.00	2,500.00
Over 1,000,000.00 to 2,000,000.00	4,000.00
Over 2,000,000.00 to 3,000,000.00	5,000.00
Over 3,000,000.00 to 4,000,000.00	6,000.00

Bidding fee shall be paid at the Office of the Municipal Treasurer upon procurement of essential bidding documents from the Bids and Awards Committee.

SECTION 3. - **AMENDMENTS.** Any ordinance, rules and regulations, or parts thereof, provisions of which are in conflict with, or contrary to the provisions of this ordinance are hereby repealed, amended and modified accordingly.

SECTION 4. - **EFFECTIVITY.** This ordinance shall take effect upon its approval and proper publication.


