MUNICIPAL ORDINANCE NO. 261
Series of 2008

AN ORDINANCE INCREASING THE MARRIAGE FEE OF FOREIGNERS FROM ONE THOUSAND PESOS (₱1,000.00) TO ONE THOUSAND TWO HUNDRED FIFTY PESOS (₱1,250.00) THEREBY AMENDING PARAGRAPH (b), SECTION 2, OF MUNICIPAL ORDINANCE NO. 216, AN ORDINANCE PROVIDING REGULATORY FEES FOR CORRESPONDING SERVICES RENDERED BY THE MUNICIPAL CIVIL REGISTRAR'S OFFICE.

SECTION 1. - **RATIONALE.** Processing marriage application of foreigners and documentation of the same entail more paper works than the local applicants hence this amendment to increase the fees thereof;

SECTION 2. - **MARRIAGE FEE. ONE THOUSAND TWO HUNDRED FIFTY PESOS (₱1,250.00).** The Marriage Fees of foreigners is hereby increased to ONE THOUSAND TWO HUNDRED FIFTY PESOS (₱1,250.00) payable with the Office of the Municipal Treasurer before filing of marriage application with the Municipal Civil Registrar's Office. This rate applies if both the couple to be married or any one of them is not a citizen of the Philippines.

SECTION 3. - **AMENDMENT CLAUSE.** All Ordinances, rules and regulations, or parts thereof, provisions of which are in conflict with, or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 4. - **EFFECTIVITY.** This Ordinance shall take effect upon its approval and proper publication.




