MUNICIPAL ORDINANCE NO. 270
Series of 2009

AN ORDINANCE PROHIBITING THE BURNING OF RICE STRAWS, VEGETATIONS, AND MUNICIPAL WASTES WITHIN THE JURISDICTION OF LOCAL GOVERNMENT UNIT OF MALAY, PROVIDING PENALTIES FOR VIOLATIONS THEREOF AND FOR OTHER RELATED PURPOSES.

SECTION 1. - **RATIONALE.** Burning of rice straws, vegetations, and household/business waste combustibles emits into the atmosphere harmful greenhouse gases/toxic wastes such as carbon dioxide, carbon monoxide, nitrous oxide sulfur dioxide, and other tiny solid particles which negatively affects the global climate change hence this piece of legislation.

SECTION 2. - **REGULATORY POLICY.** It shall be prohibited of any person, natural or juridical, to burn rice straws, vegetation, household and business waste and combustibles.

SECTION 3. - **PENALTIES.** Any person, natural or juridical who violates this ordinance shall be imposed the following penalties:

FIRST OFFENSE - Stern Warning

SECOND OFFENSE - ₱1,000.00 and warning to cancel business permit, in case of business entities.

THIRD & SUBSEQUENT OFFENSES - ₱2,500.00 and cancellation of business permit in case of business entities.

SECTION 4. - **EFFECTIVITY.** This ordinance shall take effect upon its approval and proper publication.


