**MUNICIPAL ORDINANCE NO. 299**  
Series of 2011

**AN ORDINANCE ADOPTING ADMINISTRATIVE ORDER NO. 2008-0029 OF THE DEPARTMENT OF HEALTH IMPLEMENTING HEALTH REFORMS FOR RAPID REDUCTION OF MATERNAL AND NEONATAL MORTALITY.**

SECTION 1. **RATIONALE.** The Local Government of Malay is concerned with the plight of every woman's pregnancy and childbirth. Maternal and infant mortality has been on the rise these recent years due to unplanned and unsupported pregnancy, pregnancy with inadequate care, delivery without proper facilities and assistance of skilled birth attendants and lack of afterbirth care. Thus, it is imperative that reforms in the health sector be introduced to reduce the risk of maternal and neonatal deaths and look after the health and safety of every mother and child.

SECTION 2. **ADMINISTRATIVE ORDER 2008-0029. ADOPTION.** Administrative Order 2008-0029 of the Department of Health, which addresses the problem in relation to maternal and neonatal mortality, is hereby adopted as part of the local ordinances of the Municipality of Malay.

SECTION 3. **EFFECTIVITY.** This Ordinance shall take effect upon approval and proper publication.


