**MUNICIPAL ORDINANCE NO. 336**  
 Series 2014

**AN ORDINANCE AMENDING CHAPTER IV (ARTICLE E) OF THE REVISED REVENUE CODE OF THE MUNICIPALITY OF MALAY INCREASING THE RATES/FEES OF LABORATORY SERVICES RENDERED BY THE MUNICIPAL HEALTH OFFICE OF LGU-MALAY.**

SECTION 1. **RATIONALE.** A perusal of Chapter IV, Article E of Municipal Revenue Ordinance No. 279, Series of 2009, requires the need to raise the old rates/fees of clinical laboratory services in order to cope up with increasing prices of supplies, the maintenance of upgraded/new laboratory facilities/machines, and in turn enhance the services to the public.

SECTION 2. **AMENDMENT.** Section 4E.01 of Municipal Revenue Ordinance No. 279, Series of 2009 is hereby amended to read as follows:

The following laboratory fees shall be collected for every laboratory service rendered by the Municipal Health Offices:

**A. HEMATOLOGY**

- 1. CBC (Complete Blood Count) . . . . . ₱ 130.00
- 2. Hemoglobin/Hematocrit . . . . . 60.00
- 3. Platelet Count . . . . . 90.00
- 4. Blood Typing
  - a. With Rh . . . . . 130.00
  - b. ABO System . . . . . 20.00
- 5. CBC (Platelet) . . . . . 200.00
- 6. WBC (White Blood Cell Count) . . . . . 20.00
- 7. RBC (Red Blood Cell Count) . . . . . 20.00
- 8. Differential Count . . . . . 40.00
