RESOLUTION AUTHORIZING THE HONORABLE MAYOR JOHN P. YAP TO SIGN THE DEED OF DONATION BETWEEN THE MUNICIPALITY OF MALAY AND THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) RELATIVE TO THE BANK'S OBJECTIVE OF HELPING LOCAL GOVERNMENT UNITS AFFECTED BY TYPHOON YOLANDA

WHEREAS, the Municipality of Malay suffered the overwhelming force of super-typhoon Yolanda, carrying wind gusts up to 250 kilometers per hour and placed the Province of Aklan under Signal No. 4 as declared by the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA);

WHEREAS, the onslaught of Yolanda has left most of the people of Malay in ruins, with damaged homes and properties and destroyed crops, putting livelihoods to a standstill and hopeful for a faster recovery;

WHEREAS, the destruction caused by the super-typhoon necessitates rehabilitation that will entail the use of additional funds to at least alleviate the suffering of the people of Malay;

WHEREAS, the Development Bank of the Philippines (DBP), in line with its objective of helping Local Government Units affected by typhoon Yolanda to rebuild damaged communities, has been benevolent to grant the Municipality financial assistance in the amount of ONE HUNDRED THOUSAND PESOS (₱100,000.00) to be credited under DBP Account Number 0750-00073190-30 of the Municipality ;

WHEREAS, the donation of DBP to the Local Government will go a long way in rehabilitating communities ravaged by the typhoon and provide those affected a glimpse of hope to start anew;


THEREFORE, Resolved, as it is hereby resolved by the Sangguniang Bayan in session duly assembled: To authorize the Hon. Mayor John P. Yap to sign the Deed of Donation between the Municipality of Malay and the Development Bank of the Philippines (DBP) relative to the Bank's objective of helping Local Government Units affected by Typhoon Yolanda.
