**RESOLUTION NO. 004**

**OMNIBUS RESOLUTION APPROVING BARANGAY ORDINANCE NOS. 18, 19, 20 AND 21, SERIES OF 2013 OF BARANGAY MOTAG, MALAY, AKLAN.**

**WHEREAS,** Barangay Motag have submitted for approval of this August Body Ordinances in furtherance of the general welfare of its constituents;

**WHEREAS,** Barangay Ordinance No. 18, Series of 2013, regulates the construction of houses, buildings and other structures within the territorial jurisdiction of Barangay Motag to monitor the fast growing populace of the Barangay;

**WHEREAS,** Barangay Ordinance No. 19, Series of 2013, regulates the posting of business advertisements within the territorial jurisdiction of the Barangay in order to maintain cleanliness and orderliness and as an additional source of revenue;

**WHEREAS,** Barangay Ordinance No. 20, Series of 2013, amends Barangay Ordinance No. 07, Series of 2008, an Ordinance prescribing fees/charges for the issuance of Barangay Clearances/Certifications, in order to augment their sources of revenue;

**WHEREAS,** Barangay Ordinance No. 21, Series of 2013, regulates non-malaynon peddlers, persons conducting business or other activities of buying and selling within the territorial jurisdiction of Barangay Motag in order to ensure safety and order within the Barangay;

**WHEREAS,** the foregoing Barangay Ordinances was thoroughly reviewed by the Sangguniang Bayan and are consistent with law and municipal ordinances;

**THEREFORE,** the Barangay Ordinances being in consonance and within the ambit of Barangay Motag's authority as provided under the Local Government Code of 1991, this Council hereby resolves, as it is hereby resolved: To approve Barangay Ordinance Nos. 18, 19, 20 and 21, series of 2013 of Barangay Motag, Malay, Aklan.


