RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION OF TOJO MOTORS, CORPORATION AS E-TRIKE SUPPLIER IN THE MUNICIPALITY OF MALAY.

WHEREAS, the Municipality of Malay adheres to the policy of efficient and effective governance as well as the utmost promotion of general welfare. It ensures the promotion of health and safety, the enhancement of economic prosperity, the maintenance of peace and order, the enhancement of the right of the people to a balanced ecology, and the preservation of comfort and convenience of its inhabitants;

WHEREAS, accreditation is a matter of government policy in the Municipality of Malay, a measure to protect the interests of the public within the Municipality, especially in Boracay Island;

WHEREAS, electric tricycles or the E-Trike, is now considered as the next mass transport system utility in the Island of Boracay, a part of the Municipality's programs in the preservation of the environment;

WHEREAS, with this program of the LGU in place, Tojo Motors Corporation, an entity duly registered with the Securities and Exchange Commission (SEC), intends to supply the sale of E-Trikes within the Municipality;

WHEREAS, Tojo Motors Corporation, in participation of the LGU's Program, have shown its willingness to conform with the Municipality's policies on the E-Trike program, namely, a letter of undertaking and compliance with SB Resolution Nos. 74 and 92, Series of 2014, on accreditation and guidelines, respectively;

WHEREAS, the Sangguniang Bayan further requires, **as a condition** for the grant of this Accreditation, that all of Tojo's existing units not in compliance with SB Resolution No. 92, Series of 2014 must be replaced accordingly;

WHEREAS, the LGU finds it necessary and expedient that Tojo Motors Corporation must be properly scrutinized for the reliability and quality of their units before selling them to the public;

THEREFORE, Resolved, as it is hereby resolved by the Sangguniang Bayan in session duly assembled to: Approve the Application for Accreditation of Tojo Motors Corporation as E-Trike Supplier in the Municipality of Malay.
