RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR JOHN P. YAP TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH MALAY TOURISM COUNCIL, INDUSTRY TRIPARTITE COUNCIL (ITL)-BORACAY, BORACAY FOUNDATION, INC., PHIL. CHAMBER OF COMMERCE AND INDUSTRY (PCCI)-BORACAY, DEPARTMENT OF TOURISM - REGION VI, DEPARTMENT OF LABOR AND EMPLOYMENT - AKLAN, DEPARTMENT OF TRADE AND INDUSTRY - AKLAN, AKLAN STATE UNIVERSITY, BUREAU OF IMMIGRATION AND DEPORTATION-BORACAY FIELD OFFICE, BORACAY TOURIST ASSISTANCE CENTER (BTAC), PHIL. NATIONAL POLICE-MALAY, PHIL. COAST GUARD-CATICLAN, CATICLAN-CAGBAN JETTY PORT ADMINISTRATION, CIVIL AVIATION AUTHORITY OF THE PHILIPPINES, DEPARTMENT OF SCIENCE AND TECHNOLOGY, TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY AND DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT-REGION VI FOR THE IMPLEMENTATION/INTEGRATION OF THE PIER-TO-PORT CONCEPT IN THE LOCAL TOURISM INDUSTRY OF THE MUNICIPALITY OF MALAY.

WHEREAS, Section 2 of R.A. 9593 known as The Tourism Act of 2009, declares tourism as an indispensable element of the national economy and an industry of national interest and importance, which must be harnessed as an engine of socioeconomic growth and cultural affirmation to generate investment, foreign exchange and employment, and to continue to mold an enhanced sense of national pride for all Filipinos;

WHEREAS, Pier-to-Port concept is designed to sustain Boracay's socio-economic and tourism growth and development, and seeks to expand coverage of service quality and productivity programs to other key players in the Boracay tourism industry;

WHEREAS, Pier-to-Port project would likewise provide productivity training and other capacity-building programs that will boost the employability of local workers in tourism marketing and promotions, a key objective the LGU-Malay endeavors to deliver;

THEREFORE, Resolve as it is hereby resolved by the Sangguniang Bayan duly assembled, to authorize the Municipal Mayor John P. Yap to enter into a Memorandum of Agreement with the above-mentioned parties and stakeholders for the inclusion/integration of the Pier-to-Port concept in the local tourism industry of the Municipality of Malay.
