RESOLUTION URGING THE LOCAL WATER UTILITIES ADMINISTRATION (LWUA) CHAIRMAN ATTY. RENE C. VILLA TO GRANT THE LONG TIME REQUEST OF TABON RESIDENTS IN BARANGAY CATICLAN, MALAY, AKLAN FOR POTABLE WATER SUPPLY.

WHEREAS, the residents of Sitio Tabon in Barangay Caticlan, Malay, Aklan have long been yearning for a supply of water, requests were made to various concerned government agencies to provide the necessary public utility but to no avail;

WHEREAS, the Local Government of Malay shares this sentiment of its constituents in Sitio Tabon, that a potable water supply be built for their provisions, as clean water is vital to sustain everyday life;

WHEREAS, Tabon residents are well aware of the cost for the supply of potable water, and they more than willing to pay for reasonable rates for the water's distribution;

WHEREAS, the Local Government emphasizes the urgency and necessity of a potable water supply for its people as the dry season is fast approaching, not to mention the delivery of public service they have long been waiting for and rely on;

THEREFORE, Resolved, as it is hereby resolved by the Sangguniang Bayan in session duly assembled: To urge the Local Water Utilities Administration (LWUA) Chairman Atty. Rene C. Villa to grant the long time request of Tabon residents in Barangay Caticlan, Malay, aklan for Potable Water Supply.


